School Fees Include:

An initial set of uniform: 2 sets of school uniform (dresses for girls, and shirt and shorts for boys), 1 set of PE (shorts and shirt) and 1 sun hat. Additional uniforms can be purchased at the school office. Meals and snacks are included in school fees.

School Fee Policy:

Primary

Registration & Deposit: A non-refundable application fee of \$500 + GST payable upon application, and a non-refundable enrolment fee of \$2000 + GST payable upon enrolment. Deposit is not payable.

Pre-School

Registration & Deposit: A non-refundable registration fee of \$2500 + GST payable upon enrolment. A refundable deposit of \$5,250 per child is payable by the Parent upon enrolment at the school. The deposit shall be repaid in full after deducting any amounts due to the school, provided a written notice is served at least 8 term weeks before the child is withdrawn. In case of insufficient notice, 50% of the deposit is retained.

Tuition Fees: School fees are billed on a termly basis, and are payable in advance before the beginning of each term, or prior to the child's first commencement date.

Accidental Insurance: In addition to the inclusive medical insurance, \$8.56 is charged each academic year for accidental insurance (inclusive with school fees). *This applies only to the Primary School programme.*

Family discount policy: 2nd child 10% discount of term fee; 3rd child 15% discount of term fee.
